STRICKLANDS IN BURROW'S CEMETERY

CRAIGHEAD COUNTY, ARIZONA

Sharon Primeau, a member from Ponca City, Oklahoma, surveyed the Burrow's Cemetery (also referred to as Burr Ridge Cemetery) in the summer of 1977. She describes this cemetery as "in very poor condition, overgrown and evidence that livestock had been in the cemetery. Many of the stones were off their bases. The cemetery is located near Lake City, Arizona, and is near a levee of the St. Francis River, but is quite remote and hard to find. There were some other graves, but the brush was so overgrown I could not get to them."

STRICKLAND AMNESTY OATHS, 1865 - 1870

Abstracted from microfilm (Microcopy #1003, Roll 1) by Nancy Cornell.

The following are Confederate Stricklands who submitted applications for presidential pardons. These applications were submitted to President Andrew Johnson under the amnesty proclamation of May 29, 1865, and does not include persons taking the amnesty oath prior to this date. From 1865 to 1867, approximately 13,500 pardons were granted to southerners who had fought for, held political office or aided the Confederacy.

MINUTES OF THE COURT OF COMMON PLEAS & QUARTER SESSIONS
NASH COUNTY, NORTH CAROLINA 1778 - 1804

Continued from Volume 2 No. 2, page 30:

February 14, 1791:

HARDY BREWER is appointed overseer of the road in the room of JOSEPH STRICKLAND.

May 8, 1791:

HARDY STRICKLAND petit juror.

Patrollers in Capt. Chapman's district included MARK STRICKLAND.

November 1791:

A deed of sale from JOHN CHITTY to HOWELL UNDERWOOD proved on oath of JACOB STRICKLAND.

DAVID STRICKLAND's taxable property to be added to the list of taxable property in Captain RUBEN TAYLOR's district, to wit: 200 acres, 2 white polls; he having failed to report it.

February 13, 1792:

A division of the estate of EDWARD MOORE, Junr. deceased, between the heirs of said deceased, as follows: JAMES MOORE's part (£ 722.65 to JAMES and SARAH TAYLOR, JUDITH FLOWERS, MARY TUCKER, WILLIAM MOORE, ELIZABETH STRICKLAND, SUKEY HUNT; EDWARD MOORE's part divided among the same people. 3 September 1791. WILSON VICK and J. BONDS.

Also the estate of ELIZABETH MOORE as follows: ISAAC MOORE's part (£37.17.5) to SARAH TAYLOR, JUDITH FLOWERS, MARY TUCKER, WILLIAM MOORE, ELIZABETH STRICKLAND, SUSANNA HUNT. EDWARD MOORE's part divided among the same people. 3 September 1791 WILSON VICK and J. BONDS.

A deed of sale from DAVID STRICKLAND to JOSHUA VICK proved by the affidavit of LEWIS VICK.

CAROLUS STRICKLAND, orphan of HENRY STRICKLAND, appears in court and chooses his brother, HENRY STRICKLAND, as guardian who entered into bond of £500. HARDY STRICKLAND and _____ PARKER sureties.

One of the jurors for the May term of court was MARK STRICKLAND.

May 14, 1792:

Summons LAZRUS STRICKLAND, son of LAZRUS STRICKLAND and EDITH his wife to appear at next court to give testimony against JAMES SELLARS for abusing the orphan of JOHN WEST.

MARK STRICKLAND was petit juror.

AUGUST 13, 1792:

THOMAS GRIFFIN overseer of the road from WHITES thence down to three miles part REVILLS and that the hands of HENRY STRICKLAND work for him.

1st Monday in November 1792:

A deed of sale from JOSEPH STRICKLAND, Junr. to JETHRO THOMAS Acknowledged.

February 11, 1793:

Jurors for the May Court 1793 included HARDY STRICKLAND.

August 12, 1793:

THOMAS CARTER is appointed overseer of the road in the room of HARDY STRICKLAND.

November 11, 1793:

Deed of sale from JOSEPH STRICKLAND and ? to EDWARD GANDY; proved by affirmation of WILSON VICK.

Ordered that ELISHA TYE, a base born child of ANN TYE, be bound to HENRY STRICKLAND to learn the art of Shoemaking. ELISHA is aged 4 years.

RECORDS FROM 1793 to 1798 May MISSING

May 1798:

A deed of sale from JOHN OWENS to MATTHEW STRICKLAND proved on oath of WILLIAM A _____ (illegible)

HENRY STRICKLAND appointed guardian of the orphans of ROBERT WILSON in the room of EDWARD WILSON who has removed himself out of the county. HENRY STRICKLAND agreeable. Bond of 300^l; sureties are ELIZABETH WILSON and ARCHIBALD GRIFFIN.

August 13, 1798:

Jurors for the November term 1798: HENRY STRICKLAND, HARTWELL HINES, WILLIAM TISDALE, WILLOUGHBY POWELL, WILLIS POWELL, JOHN WILLIAMS.

August 13, 1798:

HENRY STRICKLAND appointed to oversee the road from HARDY STRICKLAND's to WHITFIELD's old field.

✓ Deed of sale from LAZARUS STRICKLAND to MARK BOWERS proved on oath of JOHN TAYLOR.

A deed of sale from DAVID STRICKLAND to HENRY STRICKLAND proved on oath of JOSEPH STRICKLAND.

Administration is, on motion, granted to HENRY STRICKLAND, on the estate of WILLIAM GAY (GUY) deceased who entered bond of £ 1,000 with JAMES WILLIAMS and JOSEPH STRICKLAND securities.

November 12, 1798:

HENRY STRICKLAND qualified as a grand juror.

An inventory of the estate of HENRY STRICKLAND deceased is exhibited in open court on the oath by the administratrix who exhibited letters of administration from Georgia.

The petition of MARY STRICKLAND, widow of HENRY STRICKLAND deceased, for the division of the lands which her husband died seized (?) and that HENRY ATKINS, BENJAMIN ATKINS, WILLIAM BUNTIN, JEREMIAH BUNTIN, and JOHN BOND be the commissioners to divide the lands of said decedant agreeable to law.

On motion, MARY STRICKLAND, widow of HENRY STRICKLAND, deceased administratrix on the estate of said deceased who entered into bond of 4,000£ with NOAH STRICKLAND, CORNELIUS JOINER and HENRY ATKINSON securities.

Ordered that the administrators of HENRY STRICKLAND deceased sell the perishable state of the said deceased agreeable to law.

February 11, 1799:

A deed of sale from JEREMIAH BUNTIN to NOAH STRICKLAND.

The order of the last court reversed and the following are appointed a jury for the purpose of laying off the dower of a tract of land on the Tar River to MARY STRICKLAND, widow of HENRY STRICKLAND, and also her share of the personal property. JEREMIAH BUNTIN, BENJAMIN ATKINS, HENRY ATKINS, MATTHEW CARTER, THOMAS CARTER, MARK STRICKLAND, JOHN BONDS, HARDY STRICKLAND, WILLIAM BUNTIN, WILLIAM HENRY, WRIGHT BONDS, ROBERT WILLIAMS, JOSHUA PIERCE and JOHN SELLERS.

(This item written in record but crossed through)

The order of the last court reversed and the following are a jury for the purposes of laying off the dower of a tract of

land on Turkey Creek to MARY STRICKLAND, widow of HENRY STRICKLAND. Viz- JOHN MORGAN, JAMES COSELL, JOSEPH PARKS, JESSE DINKINS, SHADRACK HAGWOOD, JOHN TAYLOR, WILLIAM TAYLOR, WILLIAM PARKS, HARDY MORGAN, ANSEL FERRELL, SIMEON STRICKLAND, THOMAS SUTTON.

JOHN BOND, WILLIAM BUNTIN, JEREMIAH BUNTIN, BENJAMIN ATKINSON, HENRY ATKINSON are appointed commissioners to divide the lands of HENRY STRICKLAND among the heirs of said deceased.

On petition of MARY STRICKLAND, widow of HENRY STRICKLAND deceased, that dower be laid off to her from the lands and personal estate of the said HENRY STRICKLAND deceased. The Sheriff is ordered to summon jury of freeholders not connected to either of the parties in affection or consanguinity to lay off her dower from the land on Tar River and also the dower part of the personal property or estate and another jury to lay off her dower in the lands of the said HENRY lying on Turkey Creek.

JOHN BONDS, Esquire, and MARK STRICKLAND, JOHN TAYLOR are appointed to view and choose the best and most convenient place for a bridge across the Tar River.

MATTHEW CARTER is appointed overseer of the road in the room of HENRY STRICKLAND.

May 13, 1799:

A deed of sale from HENRY STRICKLAND to JOSEPH STRICKLAND acknowledged.

Bridge across Tar River to be built at old mill of HENRY ATKINS - JOHN BONDS, MARK STRICKLAND, JOHN TAYLOR.

A division of the land of HENRY STRICKLAND exhibited in court by the Sheriff.

August 12, 1799:

Ordered a road be opened from ETHELDRED DANCERS to Duncan Dees Mill and HARDY STRICKLAND is among those appointed to lay off the road.

Jurors for the November Court 1799 included HENRY STRICKLAND and MARK STRICKLAND.

A deed of sale from HENRY BURGE to HARDY STRICKLAND proved on oath of JOHN BONDS.

✓ LAZRUS STRICKLAND, son of JOHN, appointed overseer of the road in the room of JOHN WADE.

November 11, 1799:

Jurors for February term 1800 included MARK STRICKLAND.

HARDY STRICKLAND has leave to turn the road past his house near to Mr. WILSON's old field.

STRICKLAND REFERENCES IN

THE HISTORY OF MADISON COUNTY GEORGIA by Paul Tabor

The History Of Madison County Georgia by Paul Tabor was published in 1974 by the Madison County, Georgia, Library Board. Calvin G. Floyd, a member of Strickland Research, Inc., carefully abstracted references to Stricklands in this history and obtained permission to reprint these references from Mr. Paul Tabor. Thank you, Calvin, for your excellent job of abstracting; and many thanks to Mr. Tabor for his generosity.

(Editor's Note: A portion of the land which was later to be Madison County was ceded by the Creek and Cherokee Indians on June 1, 1773. The original county of Wilkes was created from this cession on February 5, 1777. By 1796, parts of Wilkes County, plus additional land gained through Creek and Cherokee cessions of 1783, had been taken to form the counties of Elbert, Franklin, Jackson and Oglethorpe. Madison County was created on December 5, 1811, from parts of Clarke, Elbert, Franklin, Jackson and Oglethorpe. Many residents, who had obtained land in original Wilkes County, became residents of several of the above mentioned counties without ever moving from their original plots of land. -NJC)

Pages 13-14:

Madison County, Georgia, was created December 5, 1811. The Act of creating the new county consisted of nine sections.

Section 6: County officers were to be elected at H. STRICKLAND's the first Monday of the following January.

Section 8: Justices of the Inferior Court will meet at H. STRICKLAND's the second Monday of the following January to "procure and select Grand and Petit Jurors."

H. STRICKLAND was HENRY STRICKLAND who lived on the county farm of today, a short distance west of Danielsville, Georgia.

Page 15:

First year of Madison County. The election of county officers was held January 4, the first Monday, at HENRY STRICKLAND's.

Page 17:

Land Court. During the year 1812, the Land Court issued 8 land warrants. One to ANCIÉ B. STRICKLAND.

I got this name and address from a copy of The Armchair Researcher at the Bay County Library in Panama City, Florida. We have several families of Stricklands (including other spellings) in our area. (Washington & Holmes Counties)

I'm not related to the Stricklands, but am chairperson of the Euchee Clan of Creek Indians at Vernon, Fla., and am trying to help some of our people trace their ancestry. (Particularly to a full blood Indian)

Mr. Jesse Strickland of P. O. Box 41, Vernon, Fla., has given me the following information and would like help. If you have any of the needed information (especially who to contact to trace his other lines) it will be appreciated.

I was so interested in Thelma Steverson's Clan and the Strickland's connected to it, I wrote her and asked permission to reprint her letter. I also asked if she could tell me a little about the Euchee Clan of Creek Indians. She replied by sending me 2 Strickland Ancestor Charts and information on the Northwest Florida Creek Indians:

The Okchals (Okchias) migrated to West Florida from what is now Central-North Alabama in perhaps the mid-1700's. The Okchals (some of whom remained in the Alabama area) were associated with the Koasati Tribe, and are credited with giving Creek place names to many West Florida geographic features. The Euchee Clan is a split from the Okchia.

The Creek Confederacy consisted of numerous associated tribes and bands. Many of their women intermarried with white traders and other frontiersmen, whose descendants often remained behind when their Indian kinsmen moved west of the Mississippi. An amazing number of such descendants, now many generations removed from their Indian ancestors, populate this area today.

There are two or three hundred in this area, plus others in surrounding counties, trying to prove their Indian ancestry. We are learning, and want our children and grandchildren to learn their native dances, arts & crafts, and language. I believe the Muscogee language is to be offered at Gulf Coast Community College in Panama City this fall.

I presume you know that the Seminoles are really Creeks. Seminole means "runaway" or "frontiersman" in Muscogee (Muskogee) language.

Thelma's name in the Muscogee language is Turwv Totkv or "Fire Eyes."
